Notification of the Disposal of the Company's Shares by Shareholders on 14 January 2011

Bumrungrad Hospital Public Company Limited (the "Company") would like to provide further information related to sale transactions on 14 January 2011 totaling 91,791,243 of the Company's shares. These transactions consist of the first sale of 42,666,243 shares and the second sale of 49,125,000 shares.

Information on the first sale has been provided in the Company's letter to the SET on 17 January 2011 which stated the following.

"Bumrungrad Hospital Public Company Limited (the "Company") would like to inform relevant parties that it has been informed by Temasek Holdings (Private) Limited ("Temasek") that investment vehicles affiliated with Temasek have initiated the sale of 42,666,243 shares."

These investment vehicles affiliated with Temasek disclosed to the SEC on 20 January 2011 that they held 0.0% shares of the Company.

The second sale reflects the divestment of 49,125,000 shares by Capital Group International, Inc. In Capital Group International, Inc.'s filing of Report of Acquisition or Disposition of Securities (Form 246-2) dated 18 January 2011, they disclosed their divestment of 49,125,000 shares or 6.7% of the total outstanding shares. After this transaction Capital Group International, Inc. held 20,373,800 or 2.8% of the total outstanding shares.

The shareholding positions of the Company's top ten shareholders, as of 30 December 2010, before the sales, and as of 20 January 2011, after the sales, are set forth below.

The share sales will not materially impact the management structure, strategy, operations, investments or financial management of the Company.

The Company (with 31.5%), Istithmar (19.5%), Temasek (19.5%), Asia Financial Holdings (19.5%) and Bangkok Bank (10.0%) are the 5 shareholders in Bumrungrad International Limited (BIL), an associate company focused on operations outside of Thailand. The Company appreciates the continued positive relationship among all shareholders of BIL.
